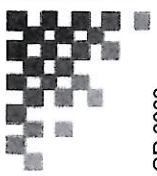

That on the 16th day of April 2025 at Adare in the Magistrates Courts District of Ipswich in the State of Queensland one Trevor Andrew HOLD obstructed a Police Officer namely Senior Constable Gregory WILEY in the performance of the officers duties

**The facts in relation to this matter are as follows:**

**Facts of the charge 1 of 1**

**The defendant in this matter is Trevor Andrew HOLD (DOB 15/04/1979).**

On the 16th day of April 2025, uniformed police attended a property where the defendant resides at 477 Gatton Esk Road, Adare in a marked police vehicle. Police attended the residence in the performance of their duties to assist an external agency, the National Fire Ant Eradication Team (NFET). NFET officers required police assistance with their planned attendance at the defendant's property due to online threats and ideologies held by the defendant in relation to the fire ant program.

Police attended the property of the defendant at approximately 8:43am on the 16th of April 2025 and spoke to the defendant and a considerable number of supporters that were present. Police introduced themselves and informed the defendant and other person's present that NFET officers would be making entry to the property to treat the property for fire ants in accordance with the Biosecurity Act. Police advised the defendant and other persons present that any person who obstructed the authorised officers would be committing an offence. They were further warned that any person who obstructed police could be arrested. The defendant requested that police leave his property and police subsequently left and returned with the NFET officers.

At approximately 8:47am police and NFET officers entered the driveway of the defendant's residence. At this time, an authorised officer from NFET introduced himself to the defendant and provided the necessary information before lawfully entering the property under the Biosecurity Act. The authorised NFET officer gave warnings to the defendant regarding obstructing officers. The defendant continually spoke over the officer and opposed the treatment of his property. Entry to the property was gained and the defendant obstructed another officer in the performance of her duties.

Police observed the defendant follow NFET officers to a gate near his dwelling. As NFET officers made their way to the yard around the dwelling, the defendant moved rapidly towards an NFET officer and yelled at the officer "This is my residence" and blocked the path of the officer. Police advised the defendant he was under arrest for obstruct. The defendant put his hands behind his back and moved away from police. The defendant continued to voice his concerns about his house yard being treated. The defendant de-escalated, and police gave him a further opportunity to amend his behaviour. The defendant walked into the rear yard of the dwelling and continued to yell at officers and blocked the path of an officer whilst yelling "Do not treat the yard". The defendant followed the officer and continued to yell "Do not treat the yard". Police confirmed with an NFET officer that they were treating the yard. At approximately 9:28am police advised the defendant that he was now under arrest for obstruct. The defendant was subsequently placed into a marked police vehicle and was transported onto Gatton Esk Road where police were met by QAS staff in relation to an injury the defendant sustained during the first obstruct. QAS subsequently transported the defendant to Gatton Hospital whilst in police custody.

At approximately 10am the arrest of the defendant was discontinued, and he was issued a notice to appear before the Gatton Magistrates Court in relation to this matter.

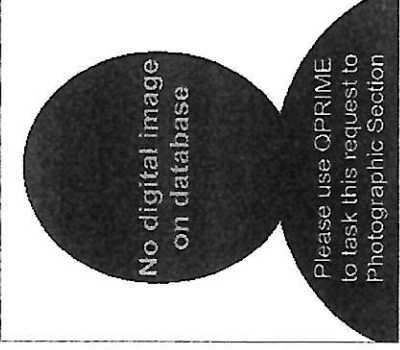
