My property was attended, yesterday 16 April 2025, by three officers, SGT Trudi Flintham, Cons Katrina Lowrey and a third officer, apparently to keep the peace and everyone safe.

Unfortunately, they instigated a breach of my peace and failed to support me to be empowered to act under 336 of the biosecurity act and obstruct biosecurity officers with my reasonable excuse, as is my right.

Trudi, particularly, assaulted me causing injury and property damage when she forced her way onto my property, without justification or cause, while I was trying to express my reasonable excuse to obstruct under the biosecurity act. This injury required medical treatment in Gatton Emergency Hospital and will require a particular care and treatment plan over the next few weeks due to the nature and place of the injury.

I was also arrested for obstructing police, while lawfully trying to obstruct biosecurity officers. I was given two obstruction Notices to Appear for the same event, 4376257/58.

Obviously, the outcome was not ideal yesterday and I am reaching out to try and rectify the situation to achieve better outcomes next time.

This issue is affecting 1000's of people across southeast Queensland and this is the second arrest for the same thing in the last few weeks. As a counsellor and mental health practitioner I am reaching out to you to see if I can negotiate a message of hope for my clients and community, who are feeling anxious, stressed and scared.

Would it be possible to organise a 'Memorandum of Understanding' and utilise the events of yesterday as a tool to create better outcomes for other people and training on the issues for attending officers?

I propose that Jim Willmott, Biosecurity consultant, Hugh Carter, Malcome Roberts legal counsel, yourself and the officers involved in the original attendance sit down and have honest discussions about what happened and how improvement opportunities can be applied for others moving forward.

I encourage you to reach out and sort this out in a community minded, consultative manner. I would hate to see more serious injuries occurred next time or for other people.

Please let me know your thoughts.
